## **Grand Jury Recommendations**


- MCTV should improve programming and bylaws
- MCTV should seek and foster new programming
- MCTV should seek more community funding
- MCTV should invite the public to participate in its board meetings

#### What is MCTV?

- Private corporation
- 501c3 nonprofit
- Operates Channel 6 as a PEG (Public, Educational and Governmental) station under an agreement with the county
- Allowed to use El Granada Comcast offices under agreement with the county

# MCTV is funded by cable fees and taxes

- Comcast adds franchise fee to cable bills
- Money is paid to the county and city
- County and city pass this on to MCTV
- But, this pass-along is not required




# MCTV Budget Year Ending June, 2008

#### Income \$112,000




## I started as an MCTV supporter

## I started as an MCTV supporter

- Supported MCTV's county funding
- Prepared a grant application for MCTV
- Then, MCTV claimed copyright on publicly-financed recordings of public meetings.
- I could only get MCTV's Station Manager to return my calls after calling MCTV's directors



# MCTV board 2008 election Week 1

- SAT April 12: I receive a copy of bylaws
  - Following months of requests
  - Deadline for board nominations is Friday
- SUN: I put together a slate
- MON: I tell the station I'm running for their board
  - I begin recruiting new members
- TUES: MCTV's attorney calls, asking "what I want"
- TUES: MCTV blocks their mail slot and tells Comcast to say Station Manager is "out of town"
- FRI: Nominations close
- SAT: MCTV mails ballots without candidate statements.
  - This allows them to close membership rolls



# MCTV board 2008 election Week 2

- SUN: MCTV announces a new copyright policy
  - When did the board meet?
  - MCTV refuses to provide minutes of board meetings
  - MCTV refuses to provide electronic membership list
- MON: Members receive ballots
  - There are no candidates' statements
  - There are new bylaws
    - Eliminate some independent board seats
    - Lower standards for conflicts of interest
    - MCTV refuses to provide a list of changes
- FRI: Candidate statements received by most members

#### No surprises in the election results


- Board-nominated candidates are elected
- New bylaws approved
- MCTV's new board includes a resident of Pacifica




#### MCTV eliminates members in 2009

- MCTV had an another board election coming up in 2009
- This year, the board submitted a yet another new set of bylaws
  - Eliminated memberships
  - Made the board self-nominating
  - Closed memberships while announcing proposed bylaws
- Clearly MCTV wasn't planning this change in 2008
  - Otherwise, why rewrite the bylaws last year?
- Is MCTV afraid of an open election of directors from the community?









#### What can be done?

- MCTV is private, so we can't change its bylaws
- The county should require that whoever runs Channel 6:
  - Be a membership organization
  - Have a member-elected board
  - Open its office and phones to the public
  - Raise revenue from the community
  - Openly solicit programming
